### The AGA and VITA

It is our pleasure to announce that the AGA Lansing Chapter will be partnering with the Asset Independence Coalition (AIC) to participate in the Volunteer Income Tax Assistance (VITA) program for the upcoming 2011 tax filing season.

The AIC is a coalition that is dedicated to engaging Clinton, Eaton, and Ingham County residents as partners in the effort to create an economically sustainable community. We believe that the goals of the AGA's community service efforts will be greatly enhanced by partnering with the AIC for this event, especially since this event our own neighborhoods bettering and is During 2011 alone, the AIC communities. completed income tax returns for 2.035 individuals and families in the tri-county area. This equated to refunds of nearly \$2.7 million, and Earned Income Tax Credits of \$672,000. There were 247 households served in Clinton County, 204 served in Eaton County, and 1,584 in Ingham County.

We encourage all of our members to participate in this year's community service outreach event, and by donating your time to help those that need assistance. The time commitment for this event is flexible and can generally accommodate your availability. You do not need prior tax preparation experience to participate!! Training and materials are provided by the Internal Revenue Service through either a classroom setting or through the IRS's Link and Learn svstem. (http://www.irs.gov/app/vita/). However, if you are interested in volunteering, please keep in mind you will need to complete a training course, before you are eligible to participate.

Further communications and updates will be provided through the news letter regarding scheduled classroom trainings, as well as when the IRS has updated their website for the 2011 tax year.

We had 44 attendees at our fall 2011 Professional Development Conference (PDC) at the Library of Michigan on Wednesday, September 28, 2011. Doug Ringler, Director of Internal Audit Services for the State of Michigan, gave an overview of what an "Internal Audit" was and was not. He also noted key differences between internal and external auditors. planning and audits, conducting internal and maximizing the benefits of having internal auditors. Becky Jo Farrington, Environmental Education Manager for Michigan Energy Options, and Julie Powers. Director Mid-MEAC. of "Implementing followed up with Environmentally Friendly Strategies". They gave tips on how to make our office more green and energy efficient. After a short break. Michelle McHale-Adams, a member of Plante & Moran's Forensic & Valuation Services Group and the Practice Leader for the firm's Investigative Services Group, delved into "Forensic Accounting Basics". She touched on forensic accounting versus fraud examination versus an audit. She focused on fraud, fraud prevention and data testing. Michigan's Acting Chief Security Officer and Director of DTMB's Office of Enterprise Security, Rich Reasner finished up our conference with "Cyber Security Trends for 2011". Rich gave some chilling trends in the cyber world and some helpful tips to lessen the effects of cyber-crimes.


